- To enhance the opportunities available for learners
- To fill gaps in niche or expert provision and/or provide better access to training facilities
- To support better geographical access for learners
- To offer an entry point for disadvantaged groups
- To give consideration of the impact on individuals with shared protected characteristics, where there might otherwise be gaps

- Expert delivery of School Sport Apprenticeships is delivered by Inspire Plus
- Performing Arts and Dance Training is supported through partnerships with Addict Dance Academy and Eastern School of Performing Arts

A dedicated team of staff led by the Executive Director Business Development support the partners to deliver a quality provision. Partnership delivery is robustly monitored and managed to ensure all of our learners have a quality learning experience. In line with ESFA guidance, we are working towards the reduction of subcontracted delivery. Exemption cases have been submitted to the ESFA for the 2022-2023 funding year. Our current management fees range between 15% and 20% depending on the level of support and risk.
